The contents of the HIP field

Name of the HIP discipline: Systematic Philosophy

The content of the HIK field of Systematic Philosophy is determined by the professional areas forming the core of the philosophy field of study. These include, on the one hand, excellent and highly qualified research in the areas of contemporary philosophical logic, criticism, methodology or epistemology, ontology, ethics, but also philosophy of culture, philosophical questions relating to the problem of consciousness, artificial intelligence and new technologies, anthropological investigations, aesthetics, or political and social philosophy. On the other hand, it also includes research dealing with the historical formation of these branches of philosophical thought regarding their contemporary forms or their normative rectifications, improvements, or revisions.

In addition to the thematic focus corresponding to the field of study of philosophy, the content of the field also includes reflection and competence in the use, improvement or formation of new methodological and interpretative tools, argumentative procedures, a reasoned critical stance, as well as competence in working with information sources of high relevance in those areas of philosophical thought in which the research in question falls. In addition to the emphasis on research and publishing in the field (with particular reference

to international excellence), the content of the HIP field of Systematic Philosophy also includes a focus on a qualified pedagogical ability to transmit knowledge to a broader or more narrowly defined professional community in informed and possibly innovative ways, as well as reflection on the formation of a philosophical school of science and the transmission of ethical values based on the foundations of humanism, democracy, freedom and justice.

Definition of the HIP field

The HIP field of Systematic Philosophy is defined by the description of the field of study in philosophy to which it is assigned. In accordance with this description, it focuses on systematic work with theoretical knowledge in all areas of philosophical research and their corresponding conceptual, interpretive, normative, and historical analyses. The HIP field of Systematic Philosophy allows only participants who have proven, measurable results of their scientific and pedagogical work in the field of philosophy and are actively developing it, to apply for the qualification process of acquiring the scientific and pedagogical title of "Associate Professor" or "Professor". For this reason, it is not intended for participants who are scientifically and pedagogically active in other fields of study listed in the system of fields of study administered by the Ministry of Education, Science, Research and Sport of the Slovak Republic, even if they fall into the same or thematically related group of fields of study in the humanities and arts. However, research carried out in these and other related fields can serve as an interdisciplinary and transdisciplinary part of the scientific work of the HIP participant in the field of Systematic Philosophy, since their philosophical reflection allows for a deeper and more accurate analysis, interpretation, critical assessment and systematization of theoretical knowledge in the areas that are determined by the supporting themes of the core of the field of study in philosophy, or as they are described in the content of the HIP field of Systematic Philosophy.
